Dasein will be installed on the corner of Ohio and Ann Streets, Clairvoyance installed at Horizon Bank and Peace Tree installed on the SE corner of Wabash and 5 Street.

4. Ram sculpture donation

Placement and naming of the Ram sculpture was discussed, but no decision was made. Hopefully a consensus will be made at the May meeting. The dimentions of the sculpture are: 8 ft. tall, 6 ft. long, 4 ft. wide and weight 6,000 pounds. Placing the Ram in the Washington Park area would be contingent on Park Board approval and the proposed work that will be done at the Fedders Alley Playground.
